1) Queensland's Economic Recovery Plan - Infrastructure Investment

BACKGROUND

- The Walker Corporation identifies itself as one of Australia's largest private development companies, across all industry sectors - retail, commercial, industrial, residential, resort and master-planned communities. Past projects undertaken in Queensland include Hope Island.
- It currently has offices in Brisbane, Redlands, Gold Coast and Ipswich, with plans for a Sunshine Coast office in the near future.
- The Walker Corporation has a current development pipeline of \$10 billion in Queensland over the next 20 years. Further details are provided at **Attachment 5**.
- A key development relates to Toondah Harbour in the Redlands Shire which includes a 200-berth marina and approximately 3600 dwellings, much of which is within the Marine Park, and a dedicated passenger and car ferry terminal.



TOONDAH HARBOUR PROJECT

Background

- The Walker Corporation (Walker) was selected as the preferred developer for this project in 2014 following a competitive process.
- Minister for Economic Development Queensland (MEDQ), Redland City Council (Council) and council's wholly-owned subsidiary, RIC Toondah Pty Ltd (RIC), formed a joint venture for the project governed by a joint venture agreement (JVA).
- Under the JVA, the MEDQ and the council agree to act jointly to oversee the project and must always act in the best interests of the joint venture
- RIC has been appointed the manager of the joint venture and is paid remuneration for this role by the MEDQ, Walker and the council. RIC represents the MEDQ under the Development Agreement (DA) and manages Walker's compliance with the DA. The MEDQ has granted RIC a power of attorney to deal with the MEDQ's land in the PDA.
- On 9 February 2016, the MEDQ, the council, RIC and Walker entered into the DA. The DA was subsequently amended via two deeds of variation on 27 February 2017 and 7 June 2019.
- The DA obliges Walker to carry out development of land, held by the MEDQ and the council, and community infrastructure over a 20-year period. The DA is subject to Walker undertaking all required environmental assessments and acquiring all relevant approvals.
- The MEDQ has primary responsibility for negotiating and registering an Indigenous Land Use Agreement with the native title holders, obtaining a reclamation lease, and converting state land tenure to freehold.

- Walker proposed master planned development includes a 200-berth marina and approximately 3600 dwellings (ranging from detached houses to multi-unit apartments up to 10 storeys), much of which is within the Marine Park, and a dedicated passenger and car ferry terminal.
- Delivery of the Walker master plan would require the Minister responsible for Marine Parks to undertake legislative amendment to revoke up to 52 hectares of the Moreton Bay Marine Park.

Environmental Impact Assessment Requirements

- On 23 July 2018, Walker's Toondah Harbour project was determined to be a 'controlled action' requiring an Environmental Impact Statement (EIS) under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). The final guideline for the EIS was issued on 3 April (2019).
- Walker is now undertaking studies for preparation of a draft EIS. The EIS will address potential impacts on wetlands subject to the Ramsar International Convention, listed threatened species and ecological communities, and migratory species.
- The EIS would have conventionally been undertaken under the EPBC Act Assessment Bilateral Agreement, enabling concurrent consideration of national and state significant environmental matters. However, the extent of development proposed within the Ramsar Wetland and Marine Park were threshold issues. The former Coordinator-General considered these issues to be sufficient reason to advise against a coordinated project declaration requiring an EIS under the State Development and Public Works

 Organisations Act 1971.
- When the Federal Government is satisfied that the draft EIS complies with the guideline, it will invite public submissions on the draft EIS for a period of six weeks. It is understood that Walker is targeting to complete the draft EIS for public review by the end of 2020.

- Should the controlled action receive Federal Government approval, it is highly likely to require significant environmental offsets and a significant subsequent assessment of matters requiring state approvals, such as marine dredging. Approval of the controlled action will trigger the obligations of the Queensland Government under the DA to take actions to progress the project.
- It is probable that the Federal Government will request that the Queensland Government clarify its position on all matters addressed in the EIS before the Federal Environment Minister will issue the EIS Assessment Report.

Compliance with the Toondah Harbour PDA Development Scheme

- Economic Development Queensland (EDQ) will be responsible for assessing and deciding a future Walker PDA development application under the *Economic Development* Act 2012 (ED Act).
- As part of a pre-lodgement process with Walker, EDQ is currently undertaking a preliminary assessment of the proposed master plan to determine whether it is consistent with the provisions of the Toondah Harbour PDA Development Scheme.

Native Title and Indigenous Land Use Agreement

- The area of the Toondah Harbour PDA is under the Quandamooka Coast Native Title claim, made on behalf of the Quandamooka People.
- The DA and JVA require the MEDQ to obtain an Indigenous Land Use Agreement which secures the surrender of all Native Title in the project area (apart from the GJ Walter Park and the Foreshore Park).
- If agreed, this would result in the extinguishment of Native Title in exchange for compensation and other potential benefits. Walker will pay the compensation costs provided the DA becomes unconditional (i.e., all approvals and tenure are obtained) and it approves the amount of the compensation).

 EDQ is in the process of finalising the details of the land in the PDA which would be included in the Indigenous Land Use Agreement. The next step is to meet with the Quandamooka People's representatives, the Queensland South Native Title Service, to agree a protocol for the Indigenous Land Use Agreement discussions.

Moreton Bay Marine Park revocation

- The proposed development requires reclamation of approximately 52 hectares of land within the Moreton Bay Marine Park. Subject to the approval of the controlled action, a Queensland Government decision on the revocation of that area would be required. To date, revocations within marine parks have been less than one hectare. Such a revocation would need to be made by Regulation subject to the assent of the Queensland Parliament.
- The development area is within an International Ramsar wetland. EDQ understands that it is not currently proposed to seek changes to the boundaries of the Ramsar area. Rather, it is understood that the Federal Environment Minister will consider whether the development can co-exist with the protected area as part of consideration of the EIS under the EPBC Act.

Community attitudes to the project

- While there is support for the project from some sections of the community opposition groups are active and well organised. Since early 2018, more than 500 letters opposing the project and Toondah Harbour is in the media almost every week.
- A 15-page 'statement of reasons' for the 'controlled action' decision by the Federal Environment Minister under the EPBC Act was reported by the ABC in late-2018. That statement highlights the significant challenges Walker faces to receive Federal Government approval for the project under the EPBC Act, especially with respect to impacts on wetlands protected under the Ramsar Convention.


- The support of the Quandamooka people would be critical to the delivery of the project. Although some Quandamooka individuals have spoken against the project, the traditional owner group's view is being reserved until the EIS is completed.
- On 29 January 2020, an e-petition was posted by the President of Redlands2030 Inc. on the Queensiand Parliamentary website. The e-petition was 'requesting the House to call on the Government to establish an independent Commission of Inquiry to investigate plans for residential and associated development on land and waters in the place known as the Toondah Harbour PDA'. The e-petition closed on 30 July 2020 and had 6063 signatures. A response is being prepared.
- On 13 July 2020, a statement was published on the Australian Conservation Foundation (ACF) website to advise that the ACF is appealing a decision to refuse access to documents relating to Walker Corportion's EIS, and the Federal Government's assessment. ACF will request the Administrative Appeals Tribunal to grant access to relevant documents.
- The ACF has also launched a campaign, including on their website, Facebook and other social media platforms related specifically to demanding laws to protect Toondah Harbour. This was a continuation of the ACF petition to demand stronger national environmental laws. As at 24 August 2020, there were 408,721 signatures.


Right to Information

- In July 2017, Redlands2030 Inc's lodged an application to the council under the Right to Information (RTI) Act 2009 for a copy of the Toondah Harbour PDA DA.
- This was refused, and Redlands2030 sought review by the Information Commissioner of the council's decision. On 21 November 2018, the Information Commissioner made a final determination that the DA should be released with minor redactions.

- Walker and the MEDQ each filed an appeal in QCAT challenging the Information Commissioner's decision, and this is before the QCAT for determination.
- At a QCAT directions hearing on 17 September 2019, orders were made for submissions by parties and a further directions hearing was held on 28 January 2020. At the hearing, Justice Daubney directed that the appeals be listed for a two-day hearing with the dates to be determined after consultation with the parties. With the onset of COVID-19, this matter will likely be scheduled for hearing in late-2020.
