## GPs continue campaign against changes to payroll tax laws

The state's GPs are continuing their campaign against what they are calling a new patient tax imposed by the Queensland Government, with fears as many as 87 per cent of clinics will have to pass on the costs.

The state's GPs are continuing their campaign against what they are calling a new patient tax imposed by the Queensland Government.

A new interpretation of payroll tax laws means general practices are now liable for an increased 4.75 per cent of total billings made by doctors who work as contractors.

Australian Medical Association Queensland president and general practitioner Dr Maria Boulton has labelled the tax "immoral".

"GP practices already pay payroll tax on our employees, the fact of the matter is that there's been a change in the interpretation of the law as pertains to patients being seen by their GPs and accessing healthcare services," she said.

"When a patient goes to a public hospital, that service is payroll tax exempt and it's exempt for a very good reason. It's because healthcare is an essential need that humans have in Australia and that is why it is so important and this is why we're here for patients.

"We're here because patients deserve to have access to their GPs."

Dr Boulton joined Royal Australian College of General Practitioners Queensland chair Dr Bruce Willett, Brisbane GP Dr Aaron Chambers and Opposition Leader David Crisafulli at a press conference to continue calls for a tax exemption on doctors working as contractors in practices.

"The RACGP has done some surveys and only three per cent of practices said that they could absorb this tax, 87 per cent of practices said that they would have to pass it on and five practices said that they would probably go broke with this new tax burden," Dr Willett said.

The Sunday Mail revealed earlier this month that the new requirement to pay tax would see the end of bulk billing and increase out of pocket costs by as much as 15 per cent.

Dr Chambers said he had no choice but to raise patient fees.

"I'm really worried about the people we don't see because I know it's exactly the people who might need health care and are most vulnerable," he said.

"We know that the people who have the lowest income are at most risk of adverse health outcomes and they're also exactly the people who are less likely to come because of that financial barrier. They're the ones I'm most worried about."

He said without sufficient federal funding to Medicare and with an added tax on patients it became impossible to support those patients.

RACGP national president Dr Nicole Higgins said it would "break general practice" and increase bed block across the state's already strained hospital system.

Opposition Leader David Crisafulli said that on 26 occasions before the last election, the treasurer promised there would be no new or increased taxes.

"Well nothing has changed for a single medical practitioner across the state, their business model remains exactly as it was and yet in the shadows of Christmas, a new tax grab was implemented that will be passed on to patients in the middle of a cost of living crisis," he said.

"Why would you charge people more to see their GP in the middle of a health crisis? Why would you funnel more people into an emergency department that is already bursting at the seams?"

Nationwide we are experiencing critical shortages of General Practitioners with demand far exceeding supply and this situation is forecast to worsen in coming years with demand for GP services projected to increase by 38.5% between now and 2032 (Deloitte). Cassowary Coast communities, along with many other rural and regional areas in Australia, are losing or have limited access to medical services, for example, the town of Mission Beach has not had a General Practitioner since late 2021 and other clinics have closed their books to new patients.

As we are all aware, the reasons contributing to the crisis in the availability of General Practitioners is complex and there is no "quick fix". Solutions that will provide our communities with long-lasting and sustainable outcomes require a concerted, coordinated and collaborative approach from all levels of government, community and industry.

Cassowary Coast Regional Council asks the Queensland Government to provide an exemption or concession in the circumstance where there is a contract between an entity that conducts a medical centre and a practitioner under the Act. This will ensure that there are not further negative impacts on already-stretched general practitioner and allied health service deliveries which will likely lead to further closures and loss of services; thereby increasing pressure on the public health system.

Gaps in critical services result in poorer health outcomes of the population, as well as have a negative impact on the liveability and ability to attract and retain families to regional and remote areas, potentially contributing to long-term economic decline within regions.

GPs and general practices have told the RACGP that if payroll tax is imposed on practice earnings almost 20% of general practices will be forced to close; nearly 80% of GPs would have to pass the payroll tax on to patients as gap payments and increased fees; and many of our GPs would leave general practice altogether.

The impacts of this matter will have a greater flow-on effect in communities that have the greatest socio-economic disadvantage and that can least afford to pay the flow-on costs that the general practices have to impose to be economically viable, or just to break-even. Cassowary Coast Local Government Area is one such region with a substantial socio-economic disadvantage with 44% of our Estimated Resident Population in the most disadvantaged quintile when compared with 20% for Queensland.

On behalf of our community, I thank you for taking our issues into consideration and would be pleased to discuss this matter with you or a member of your team further should the opportunity arise.

This is a complex national issue.

I am advised that there has not been any change to how payroll tax is applied to medical practices.

Unlike other States the Queensland Revenue Office is not targeting medical practices with audits.

The Treasurer is working with the Royal Australian College of General Practitioners and AMAQ and is continuing to engage on this issue.

The Queensland Revenue Office has already agreed to limit the time period of audits on GPs (to the 2021-22 financial year and future years).

This is an issue that could be considered at National Cabinet alongside the reform of GP payments.

The biggest challenge remains the issue of GP payments and the impact that has on finding a bulkbilling GP.

My government has been consistently raising the need to improve access to GPs. People who are unable to access GPs are continuing to present at hospitals and emergency departments.

"As the Acting Premier and the RACGP made clear earlier this month, the biggest challenge facing general practice is a decade of neglected primary health care.

Like other states, Queensland is calling for an overhaul of funding for primary health care.

Unlike other states, Queensland's revenue office does not specifically target GP clinics for payroll tax compliance.

Ongoing payroll tax exemptions for particular sectors would only create distortions that would increase the tax burden on other Queenslanders."

## Background:

Payroll tax is an important source of revenue to support the Palaszczuk Government's investment in Queensland, including schools, roads and hospitals.

Like other revenue offices around Australia, the Queensland Revenue Office has determined that in certain employment situations, people employed as contractors are treated as employees when it comes to payroll tax.

The industries most affected by this ruling are building, construction, cleaning and security.

Many GP clinics are also liable for payroll tax as their GPs are employed as contractors.

The RACGP asked the Queensland Revenue Office for a determination around the applicability of payroll tax to GP clinics.

That determination supported the treatment that had already been in place.

the Queensland Revenue Office, but at the moment by the Acting Commissioner of State Revenue. That's how it should be we shouldn't have politicians deciding how people comply with the tax laws of this state. Like income tax, payroll tax is self-assessed. That means a business determines whether it's liable for payroll tax, possibly taking advice from accountants and lawyers, and like income tax compliance is undertaken by the Revenue Office, and in this case, the Queensland Revenue Office. I'm advised by the Acting Commissioner of State Revenue that the Queensland Revenue Office routinely undertakes compliance activities relating to contractor payments. Contractors from a payroll tax point of view come from industries like business, a building construction, and cleaning and security. A small number of these contractors are GPs. Compliance activities are central to ensuring that payroll tax is being administered correctly and in a consistent manner for all taxpayers. People might not like paying tax but I'm sure everyone would agree, it's appropriate that people pay their fair share. I'm advised the Queensland Revenue Office is not specifically targeting general practitioners and medical practices in its compliance activities. That's unlike New South Wales, Victoria, Western Australia and South Australia, where the GPs' own newsletter points out revenue officers are specifically targeting medical practices. Depending on the specific circumstances, it's possible that medical practices may be detected as part of the Queensland Revenue Officer's standard compliance approach. Medical practices that use contract arrangements may be the subject of payroll tax compliance in the same way as other industries that use contractors.



## **Payroll Tax – General practitioners and medical practices**

## Recommended response

- The Queensland Revenue Office (QRO) undertakes compliance activity to ensure employers are accurately determining their liability and payroll tax is being administered correctly.
- QRO is not specifically targeting general practitioners and medical practices in its compliance activities.
- QRO targets compliance activities using available data, based on objective risk-based revenue management principles.
- Medical practices that use contractor arrangements may be subject to a payroll tax compliance audit, in the same way as any other industry. QRO's compliance activities have identified employers across a range of industries, including medical practices.
- In a small number of recent investigations, medical practices have been required to back-pay payroll tax to meet their obligations.
- QRO has resumed normal compliance activities that were suspended due to the COVID-19 pandemic. These factors may mean that more medical practices are subject to compliance activity, but this is not the result of any focus on industry or type of business and is unrelated to recent court cases.
- QRO has reviewed the recent NSW decision of *Thomas and Naaz Pty Ltd v NSW Chief Commissioner of State Revenue*, and the principles from that decision are consistent with the longstanding approach that has been applied in Queensland when determining the payroll tax consequences of similar arrangements.
- There have been no changes to the contractor provisions in payroll tax legislation, or QRO's interpretation of them, following the *Thomas and Naaz* decision.
- QRO is supporting medical practices to understand and meet their payroll tax obligations. Consequently, on 23 December 2022, <u>Public</u> <u>Ruling PTAQ000.6.1 Relevant Contracts - Medical Centres</u> was published.
- QRO is continuing to work with peak medical bodies on this issue, including ongoing consultation regarding the Public Ruling.

## **Key Facts**

- Under the Payroll Tax Act 1971, payments made to contractors are subject to payroll tax, unless an exemption applies.
- The approach in relation to administering these contractor provisions for medical practices is longstanding and has not recently changed. In their current form, these provisions in the *Payroll Tax Act 1971* have been in place since 2008.
- In view of the potential lack of awareness of the relevant contractor provisions among general practitioners, and in recognition that further clarity regarding the application of the contractor provisions was provided in 2021 in the New South Wales *Thomas and Naaz* case, the Acting Commissioner of State Revenue has decided that audit activity in relation to the application of the contractor provisions as they relate to general practitioners will be limited to 2021-22 and subsequent financial years. Arrangements of this nature are not commonplace.
- Details regarding this limitation for general practitioners will continue to be worked through and will be advised to peak medical bodies once completed.
- QRO has welcomed positive discussions with peak medical bodies and encourages them to continue to work with QRO.

## Achievements

- The 2022-23 State Budget delivered a record commitment for frontline health services and high-quality healthcare infrastructure.
- Queensland has a competitive payroll tax framework, and the government is providing payroll tax relief to small and medium businesses across the state through an adjustment to the existing payroll tax deduction framework that took effect on 1 January 2023.
- On 1 January 2023, the ceiling on payroll tax deductions was extended from \$6.5M in wages up to \$10.4M, with the phase out rate being increased to \$1 for every \$7 of taxable wages above the \$1.3M threshold. Prior to this change, the payroll tax deduction phased out at a rate of \$1 for every \$4 of taxable wages.
- Additionally, Queensland's payroll tax exemption threshold of \$1.3M is one of the highest thresholds of all states and territories, meaning that most small businesses would not be liable for payroll tax. The standard rate of payroll tax 10 and 12 be readed and the lowest tax

rates compared to other jurisdictions, and there is a one percentage point discount for eligible regional employers.

## Background

- There have been media reports about payroll tax issues relating to medical practices. Media reports have alleged that:
  - QRO has changed the way it interprets and applies the "relevant contract" provisions in the Payroll Tax Act 1971 following the NSW decision in Thomas and Naaz;
  - QRO is specifically targeting medical practices in payroll tax audits; and
  - increased payroll tax liabilities for medical practices (or having to "backpay" payroll tax for multiple prior financial years) will place further pressure on the health system and will ultimately impact patients.
