THE Newman Government has been accused of giving favourable treatment to a North Stradbroke Island sand mining company after it was revealed the office of Natural Resources and Mines Minister Andrew Cripps met Sibelco eight times in two months.

At the Budget Estimates hearing today, Labor MP Jo-Ann Miller suggested Mr Cripps had provided company representatives and advisers with an "extraordinary level of access" in May and June.

"It's a filthy, dirty rotten deal that's going down in your government isn't it?" Ms Miller said.

But Mr Cripps said the government had approached Sibelco and challenged them to come up with an "alternative package of arrangements to continue their mining activities beyond what had been indicated in 2011 legislation brought in by the previous government".

"We challenged them to come up with a package of alternative proposals that would see the transition process for the community on North Stradbroke Island be smoother to other economic activities, to ensure people on the island including indigenous people have employment opportunities," Mr Cripps said.

"The proposal that's come forward from Sibelco involves an extension of sandmining on the island till 2035."

He said the proposal was being considered.

Sibelco was among the donors to Premier Campbell Newman's election campaign in the seat of Ashgrove, but Mr Cripps said that had no relationship with the current negotiations.

"I think there was a lot of stakeholder groups who had an interest in the campaign in Ashgrove at the last state election and there would've been a lot of resources put into that campaign for all political parties involved," said Mr Cripps.

CALLER:

Look my question is about will you uphold the state's native title agreements with the Quandamooka people on Stradbroke and rule out extending Enterprise Mine in either time or area because the legislation ends at the moment at 2019, and that is reflected in the ILUA. And secondly, how do you explain all the secret meetings that Minister Cripps' advisor is having with Rolands and Sibelco, and I understand there were a lot of meetings in May revealed in Estimates, and some of those were talking about legislation amendments.

PREMIER:

Hmm, well Jan, I will answer it in this way. Going back to probably 2011, I came out very clearly on the public record, and I think it was around about June, I could be wrong about the month, but it was in the middle of the year roughly, and I said that if we were re-elected we would extend the mine life til beyond what Anna Bligh had said. So Anna Bligh bought it back, we said we would put it back to where it was at least. That is what I said. My understanding from talking to Mark Robinson who is the member for that part, the Member for Parliament, he actually says that he felt that the state LNP had said the previous year the same stuff, they'd actually said no, no they were committed to a longer mine life. So my position is that we said it, we said it clearly. It was a big campaign issue. It was considered by the people of Stradbroke Island, and there are three polling booths on the island, and people went into those polling booths with that knowledge about who was proposing what, so they could have gone with Anna Bligh who'd made a commitment to cut the mine life, shut it down, and they had the LNP position which was to extend mining, and people voted for us. So, three polling booths on the island, I am advised we had never won all three polling booths, we won all three polling booths.

STEVE AUSTIN:

But is a member of Andrew Cripps' staff having secret meetings in the island with a view to changing the legislation?

PREMIER:

Well, there are no such things as secret meetings.

STEVE AUSTIN:

Okay, well meetings the public is not advised of.

PREMIER:

Well Steve, this government publishes Ministers diaries. You didn't get that from Anna Bligh or Peter Beattie.

STEVE AUSTIN:

And are they discussing changing the legislation?

PREMIER:

Well of course there are discussions about changes to bring into effect the actual commitment. But again, we put that to people... See, this is the thing, I know the ABC 7.30 Report ran this the other night as sort of

some big secret. But again, you can't be clearer than this: upfront, prior to an election we said we will extend the mining. We said that. And people on Stradbroke Island voted for us, very significantly.

STEVE AUSTIN:

So in other words, people supported your moves...

PREMIER:

People supported our move. As to the treatment of the Quandamooka, there are many people of an indigenous background who work in the mine. And maybe they are not being heard here as well. We are going to do the right thing by the Quandamooka, I say that, but we are also going to respect the voice of people at the polling booth, that is very important. I've got to say I was disappointed that the 7.30 Report didn't cover the other night, this issue on the actual election result, because it speaks volumes about the openness that we show, and the good faith we showed, and then the decision the island has made.
